## **Your Medical Record**

I am required by the College of Physicians and Surgeons of Ontario to store all original patient records for a period before they can be destroyed. Your medical record does not automatically follow you when you leave a medical practice, unless you arrange for it. I have selected RSRS, a physician-managed company, to safely and securely store all patient records from my practice, and to assist you in obtaining a certified and searchable copy for yourself and/or your new physician.

<u>I encourage you to obtain a certified copy of your personal medical history</u>. It is a very important file for your continued care and should be accessible at all times, especially in the absence of a new doctor. Please contact RSRS in one of the following ways:
